- 1. You will obtain a Sex Offender Evaluation from a certified Sex Offender Treatment Provider who is approved by the Lawrence County Adult Probation Office and pay the costs of evaluation/ treatment to the treatment provider. You must comply with and successfully complete all treatment recommendations, resulting from your evaluation. You must also provide written authorization for release of confidential information between your Sex Offender Treatment Provider and the Lawrence County Adult Probation Office
- 2. You will undergo a polygraph examination when instructed by the Adult Probation Office and/or your Sex Offender Treatment Provider. The polygraph must be administered by a certified polygraph examiner who is approved by the Adult Probation Office and/or your Sex Offender Treatment Provider. You shall pay a monthly fee, as an additional cost, as part of the Sex Offender Accountability Program to the Adult Probation Office.
- 3. You will abstain from the use or possession of any medications or supplements designed or intended for enhancing sexual performance or treating erectile dysfunction without prior written approval of the Adult Probation Staff and/or your Sex Offender Treatment Provider.
- 4. You will not have any contact with your victim(s) or your victim(s) family. The includes direct or indirect contact, written correspondence, telephone, email, text messages and/or contact through a third party. You must immediately report to your Probation Officer any incidental contact you may have with any victim(s) or prohibited persons. Contact, for the purpose of this Condition and all other Conditions, is defined as follows: (1) actual physical touching; (2) writing letters, sending messages, buying presents, sending email, sending instant messages, sending text messages, call on a telephone/cell phone; (3) and verbal communication, such as talking, as well as nonverbal communication, such as body language (waving, gestures, winking, etc.), sign language and facial expressions. Any scheduled contacts must be approved by your Adult Probation Office and/or your Sex Offender Treatment Provider prior to any contact.
- 5. You will not possess, view, listen to or read any sexually explicit articles, literature, books, pornography, magazines, photographs, emails, websites, electronic storage (CD-ROM's, DVD's, etc.), tapes or videos. Sexually explicit, for the purpose of this Condition and all other Conditions, is defined as actual or simulated depiction of the following: (1) sexual intercourse, including genital genital, oral genital, anal genital, hand genital or oral anal intercourse; (2) bestiality; (3) masturbation; (4) sadistic or masochistic abuse; (5) exhibition of the genitals or pubic area of any person; and (6) nudity.
- **6.** You will not enter adult bookstores or any establishment whose primary function is the sale, rental, or display of any sexually explicit materials.
- 7. You will not enter massage parlors or establishments that feature exotic dancers, nude or partially nude entertainers or any place that allows the viewing of sexually explicit material or where you can obtain sexually explicit services. Partially nude is defined as exhibiting the breasts, nipples, genitalia, buttocks, midriff, or pubic area of the individual.
- 8. You will not access or participate in any sexually explicit telephone services, such as 900, 970, or 877 phone numbers.
- **9.** You will not join or maintain a membership, be part of a mailing list or associated with any group or club whose primary purpose is to promote, discuss or participate in sexual activity. This includes internet chat rooms, etc.
- **10.** You will not patronize or have any contact with prostitutes or escorts services.
- **11.** You will not hitchhike or pick up hitchhikers.
- 12. You will not access the Internet or possess a computer that has Internet access without prior written permission of your Probation Officer. You must provide your Probation Officer unlimited access to any computer or other wireless/electronic device in your possession, including, but not limited to, cellular phones, "smart" phones, etc., and allow your Probation Officer to search all programs and records maintained on any computer or such other device in your possession. You must submit all cable and phone bills to verify that you do not have internet services.
- 13. You will comply with all Sex Offender registration and statutory requirements. This includes reporting and providing all required information to law enforcement authorities within 48 hours of any permanent or temporary change in your residence, employment or education.

- 14. You will comply with all Sex Offender registration and statutory requirements. This includes reporting and providing all required information to law enforcement authorities within 48 hours of any permanent or temporary change in your residence, employment or education.
- 15. You will reside at your approved residence. You must not sleep or stay overnight at any other address or location without prior written permission of Probation Officer.
- 16. You will not obtain employment (either as a volunteer or compensated worker) that places you in routine physical contact with others, including, but not limited to, attendant care worker, child care, massage etc. Physical contact is defined as direct or indirect touching of another causing a part of the body to come into contact with another.
- 17. You will not obtain employment (either as a volunteer or compensated worker) that places you in a position where you are in charge of or have control, power of authority over vulnerable individuals. Vulnerable individuals are defined as persons who are elderly, physically, intellectually and/or emotionally disabled and anyone under the age of 18.
- 18. You will not have any contact with anyone under the age of 18 years old. This includes direct or indirect contact, written correspondence, telephone contact or contact through a third party. You must immediately report to you Probation Officer any incidental contact with anyone under the age of 18 years old. Contact, for the purpose of this Condition and all other Conditions, is defined as follows: (1) actual physical touching; (2) writing letters, sending messages, buying presents, sending email, sending instant messages, sending text messages, call on a telephone/cell phone; (3) and verbal communication, such as talking, as well as nonverbal communication, such as body language (waving, gestures, winking, etc.), sign language and facial expressions.
- 19. You will not reside in any residence or dwelling where a person under the age of 18 years old resides. Persons under the age of 18 years old must not visit or be present in your residence or on your property.
- 20. You will not reside, enter or loiter within 1,000 feet of areas where the primary activity as such locations involve person under the age of 18 years old, including playgrounds, youth recreation centers, arcades, amusement parks child daycare centers, elementary schools, high schools, elementary/high school bus stops, Special Olympics, Boy Scout/Girl Scout meetings/events or any other similar areas where person under the age of 18 years old congregate, without prior written permission of your Probation Officer.
- 21. You will not work or loiter within 1,000 feet of areas where the primary activity as such locations involve person under the age of 18 years old, including playgrounds, youth recreation centers, arcades, amusement parks child daycare centers, elementary schools, high schools, elementary/high school bus stops, Special Olympics, Boy Scout/Girl Scout meetings/events or any other similar areas where person under the age of 18 years old congregate, without prior written permission of your Probation Officer.
- 22. You will not be employed or attempt to engage in any occupation, either as a volunteer or compensated worker, at any place that serves or employs anyone under the age of 18 years old or place you in direct contact with anyone under the age of 18 years old, without the prior written permission of you Probation Officer.
- 23. You will not form any intimate or romantic/sexual relationship with any person who has full or partial physical custody, including visitation rights, or anyone under the age of 18 years old.
- 24. You will not participate, directly or indirectly, in any child sponsorship-type organizations or activities, including, but limited to, Big Brothers/Big Sisters, Boy Scouts/Girl Scouts, foster child programs, fundraiser events conducted for or by person under the age of 18 years old, sponsoring/providing financial support to needy children overseas, sponsoring a child in a walk-a-thon/run-a-thon event etc.
- 25. You will not possess photographs or other pictures of anyone under the age of 18 years old without prior written permission of your Probation Officer.
- 26. You will not purchase or possess items designed to appeal primarily to persons under the age of 18 years old, including but not limited to, children's clothing, toys, games, video gaming systems (such as Wii, Playstation, Xbox, etc.), books, dolls, stuffed animals, child-oriented videos, etc.

ACKNOWLEDGEMENT BY PARTICIPANT

You expressly consent to the search of your person, property and place of residence without a warrant by officers of the Adult Probation and Parole Department of Lawrence County. Any items present which constitute a violation of your supervision shall be subject to seizure and may be used as evidence in the revocation process. You further understand that all electronic devices including, but not limited to, computers, camera, digital cameras, video recorders, cell phones and any other device in your residence or under your control are subject to search by officers of the Adult Probation Office.

You hereby acknowledge that you have read, or have read to you the foregoing conditions of your supervision. You fully understand them and agree to follow them and fully understand the penalties involved should you violate them.
