      - The bid packet for Round 1 -2025 was emailed to our qualified contractors on October 14, 2025. All bids are due back at 11:30AM, November 18, 2025. Bids will be opened immediately, and the results will be emailed for review. We would like to award the contracts at the November 25,2025 meeting.

#### Mobile Homes

■ One of the repository properties in Round 1 – 2025 is a mobile home located in a mobile home park in Shenango Township. The mobile home is located in the floodway and once removed cannot be replaced. We have received a signed agreement from the property owner allowing us access to the property to remove the mobile home.

#### Façade Program –

 2026 Guidelines – Guideline changes for 2026 were discussed and will be presented to the board for approval at the November 2025 meeting.

- 2026 Funding Staff will look at previous years funding and make a recommendation as to how much will be allocated for the 2026 year.
