We will be requesting a quarterly disbursement of ACT 152 funds from the Commissioner's and starting July 8th, the ACT 48 fees will start being collected.

- First Merit Site 25 N. Mill Street DORE & Associates have started site restoration at the former First Merit property. R.A.R. Engineering Group has been monitoring the process.
- Rite-Aid Site 119 E. Washington Street R.A.R. Engineering Group and the City of New Castle are working with the property owner to get the site secured and cleared of debris.
- All Aboard Ellwood 236 4th Street Ellwood City Construction on this project must start by February, 2026. As defined by our agreement, beginning construction is applying for the building permit, receiving it and breaking ground within 30 days of the date of the permit.
- Repository Demolitions We have two properties currently on the list but will
 wait until we have reviewed the updated repository list from the Tax Claim
 Department in August before we put anything out to bid.
