The Lawrence County Commissioners' Meeting of Tuesday, May 27, 2025, was called to order by **Commissioner Daniel Vogler**, at 10:00 AM at the Lawrence County Commissioners Meeting Room. Maggie Miller from Mercer County (originally from Lawrence County), discussed the Savanah Cemetery in Shenango Township. She stated her parents and a lot of Veterans are buried there. No one takes care of it and maintains it. There is very high grass and garbage thrown over the hill on one side. Who owns it, who does she contact, where does she go?

Mr. Vogler stated that by State law, Counties do not have the legal authority to maintain cemeteries (unless they are owned by the County, such as the former Hill View Manor Home). Mr. Vogler suggested Maggie contact Shenango Township, as there is language in the Township Code that pertains to cemeteries. Mr. Vogler further suggested she speak with Andrew Henley. Mr. Bob Bruce purchased one side of the cemetery and pays someone to maintain it. Mr. Venasco stated on the County's website, there is a section where she can look up who owns every property in the County. She will come up to the Commissioners' Office after the meeting.

Carissa Neary and Isabelle Daniels thanked the Commissioners for their continued support for the New Castle Library. The Commissioners signed (2) support letters for the COVID-19 ARPA Capital Projects Fund Digital Connectivity Technology Program and also for the Installation of Book Lockers at Shenango Township Community Park. NOW, THEREFORE BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF COMMISSIONERS, that,

- The County shall enter into the agreement with Lawrence County Social Services, Inc. as detailed in the attached contract designated as R – 2025 - _____ for the management and delivery of emergency shelter and other case management services to the homeless under the provisions of the 2024-2025 Homeless Assistance Program.
- 2. This Agreement shall be in effect from July 1, 2025 to June 30, 2026.

- 3. The contract allocation during the term of this Agreement is \$ 153,077 or as adjusted by the Pennsylvania Department of Public Welfare, plus interest earned thereon. This agreement shall include any additional funding provided by the Department of Public Welfare for use under the Housing Assistance Program.
- 4. The Chairman Commissioner is granted permission to sign any and all documents pertaining to the application and administration of such funds.

WHEREAS, Lawrence County Social Services, Inc. desires to continue to provide services under the Human Services Development Fund (HSDF) to the County of Lawrence.

NOW, THEREFORE BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF COMMISSIONERS, that,

- 1. The County shall enter into the agreement with Lawrence County Social Services, Inc. as detailed in the attached contract designated as R 2025 _____ as a provider of services to County residents eligible under the provision of the 2024-2025 Human Services Development Fund..
- 2. This Agreement shall be in effect from July 1, 2025 to June 30, 2026.
- 3. The contract allocation during the term of this Agreement shall be \$ 114,423 or as adjusted by the Pennsylvania Department of Public Welfare, plus interest earned thereon. The County shall be responsible to pay LCSS for the provision of services only to the extent the County actually receives such funds from the Commonwealth.
- 4. LCSS agrees to adhere to all state administrative provisions that are appropriate as published in the 2025-2026 HSDF Instructions and Requirements Manual.
- 5. The Chairman Commissioner is granted permission to sign any and all documents pertaining to the application and administration of such funds.
