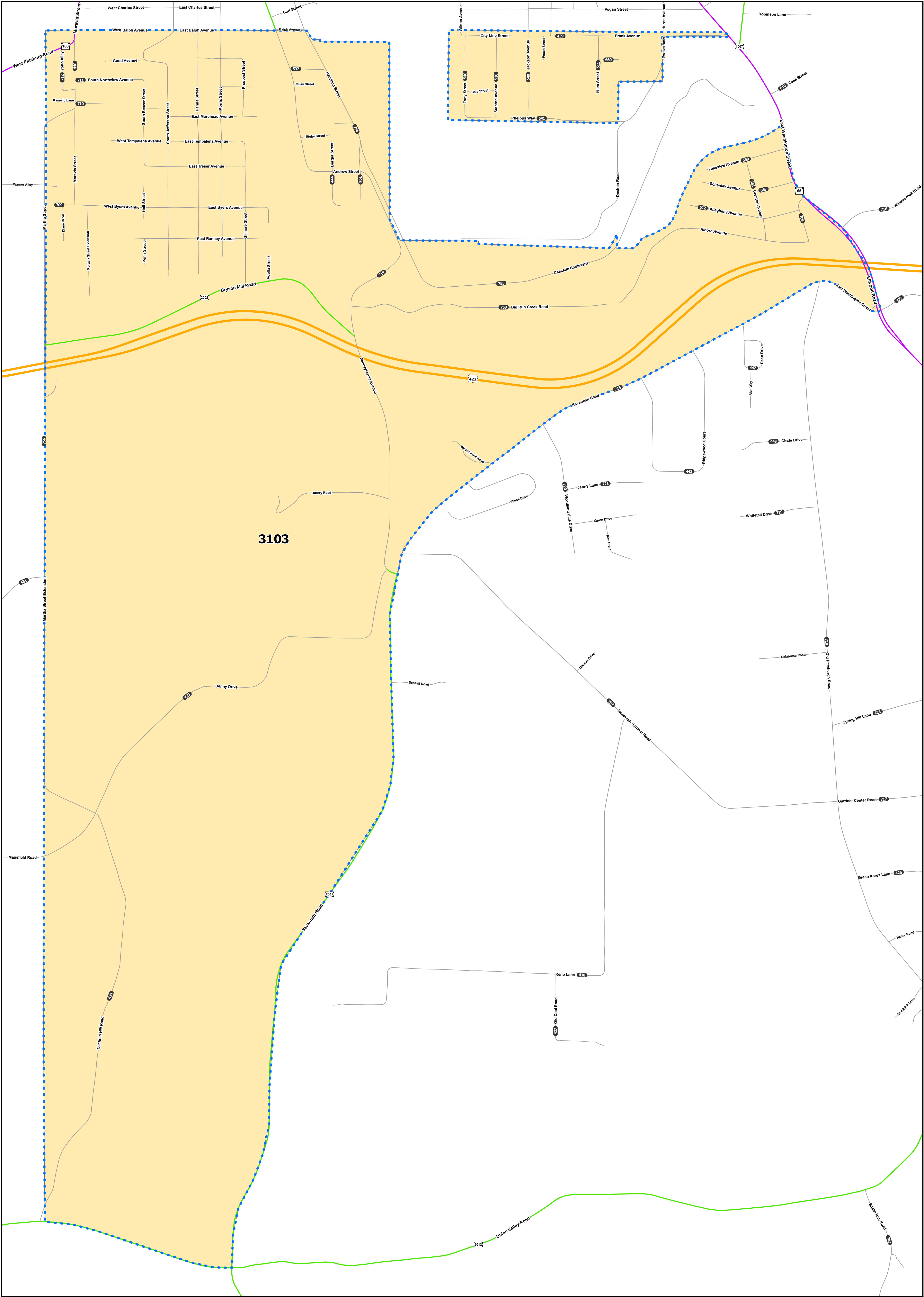
## SHENANGO TOWNSHIP

### THIRD (3<sup>RD</sup>) DISTRICT, PART 1

THE NORTHWEST CORNER IS BOUNDED BY THE TAYLOR TOWNSHIP LINE AND THE NEW CASTLE LINE; GOING EAST FOR 4/5 OF A MILE, FOLLOWING THE NEW CASTLE LINE; GOING SOUTH FOR 1/2 OF A MILE, FOLLOWING THE NEW CASTLE LINE; GOING EAST FOR 3/4 OF A MILE, FOLLOWING THE NEW CASTLE LINE, COMING TO EAST WASHINGTON STREET (PA ROUTE 65); GOING SOUTHEAST FOR 1/2 OF A MILE, FOLLOWING EAST WASHINGTON STREET AND ELLWOOD ROAD, COMING TO SAVANNAH ROAD; GOING SOUTHWEST FOR 3 1/4 OF A MILE, FOLLOWING SAVANNAH ROAD, COMING TO UNION VALLY ROAD; GOING NORTHWEST FOR 1/2 OF A MILE, FOLLOWING UNION VALLEY ROAD, COMING TO THE TAYLOR TOWNSHIP LINE; GOING NORTH FOR 2 9/10 OF A MILE, FOLLOWING THE TAYLOR TOWNSHIP LINE, TO THE BEGINNING OF THIS DISTRICT.

### THIRD (3<sup>RD</sup>) DISTRICT, PART 2

THE NORTHWEST CORNER IS BOUNDED BY THE SHENANGO TOWNSHIP LINE AND THE NEW CASTLE LINE; GOING EAST FOR 2/3 OF A MILE, FOLLOWING THE NEW CASTLE LINE, COMING TO EAST WASHINGTON STREET; GOING SOUTHEAST FOR 60 FEET, FOLLOWING EAST WASHINGTON STREET, COMING TO THE SOUTH RIGHT OF WAY LINE OF FRANK AVENUE; GOING WEST FOR 1/6 OF A MILE, FOLLOWING THE SOUTH RIGHT OF WAY LINE OF FRANK AVENUE, COMING TO DESHON ROAD; GOING SOUTH FOR 1/10 OF A MILE, FOLLOWING THE NEW CASTLE LINE; GOING WEST FOR 1/10 OF A MILE, FOLLOWING THE NEW CASTLE LINE; GOING SOUTH FOR 1/10 OF A MILE, FOLLOWING THE NEW CASTLE LINE, COMING TO THE SOUTH RIGHT OF WAY LINE OF PHELPPS WAY; GOING WEST FOR 2/5 OF A MILE, FOLLOWING THE SOUTH RIGHT OF WAY LINE OF PHELPPS WAY AND THE NEW CASTLE LINE; GOING NORTH FOR 1/5 OF A MILE, FOLLOWING THE NEW CASTLE LINE, TO THE BEGINNING OF THIS DISTRICT.

### **NOTICE TO THE VOTERS OF SHENANGO TOWNSHIP PRECINCT 3 AND FORMER BOROUGH OF SOUTH NEW CASTLE LAWRENCE COUNTY, PENNSYLVANIA**

The Lawrence County Board of Elections has filed with the Court of Common Pleas, Civil Division of Lawrence County, Pennsylvania, a Petition recommending that the former Borough of South New Castle, Lawrence County, Pennsylvania, consisting of one precinct with 442 voters be consolidated into the following precinct:

Shenango Township Precinct 3, which currently consists of 647 registered voters.

The proposed Shenango Township Precinct 3 will consist of 1,089 registered voters.

A hearing on the Petition of the Lawrence County Board of Elections will be held on February 6th, 2026, at 9:00 a.m. in Courtroom 2, 430 Court Street, New Castle, PA, 16101, President Judge J. Craig Cox presiding.

Any person objecting to the proposed Shenango Township Precinct 3 shall provide their objections in writing and file the same with the Lawrence County Prothonotary's office, 2nd Floor, Lawrence County Government Center, 430 Court Street, New Castle, PA, 16101 on or before February 5th, 2026 at 4:00 p.m.
