RACP Grant –

We have a six-month extension letter prepared for signature at today's meeting. This is the first of three (3) six-month extensions we can request should it become necessary.

o ACT 48 Ordinance Update -

■ The Commissioners passed the ACT 48 ordinance on April 8th, 2025. It will go into effect on July 8th, 2025. This ACT allows for a \$250 fee to be assessed on every foreclosure, mortgage, sheriff sale and repository property sale.
