NEW BUSINESS

RESOLUTION R-2025-316

WHEREAS, the Lawrence County Department of Public Safety has entered a professional service agreement with Dell Financial Services, L.L.C., One Dell Way, RR8-23, Round Rock, Texas78682, to provide a five (5) year Service Agreement, attached hereto as Exhibit "A".

WHEREAS, Dell Financial Services, L.L.C. agrees to provide a five (5) year Service Agreement in the amount of Two Hundred and Seven Thousand Five Hundred Forty-five and sixty (\$207,545.60) Dollars to be paid annually in the amount of Forty-Seven Thousand Thirteen and Forty-four (\$47,013.44) Dollars. This agreement will not be construed to create a partnership, joint venture or employment relationship between DELL FINANCIAL SERVICES, L.L.C. and LAWRENCE. DELL FINANCIAL SERVICES, L.L.C. will not represent itself to be an employee or agent of LAWRENCE and cannot enter into any agreement on LAWRENCE's behalf or in LAWRENCE's name without express written authorization from a duly authorized representative of LAWRENCE to do so.

NOW, THEREFORE, BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF COMMISSIONERS that authorization is given to execute on behalf of the Lawrence County Department of Public Safety, all documents related to the Dell Financial Services, L.L.C. service agreement to provide a five (5) year agreement. Dell Financial Services, L.L.C. will perform the services not to exceed the total amount Two Hundred and Seven Thousand Five Hundred Forty-five and sixty (\$207,545.60) Dollars to be paid annually in the amount of Forty-Seven Thousand Thirteen and Forty-four (\$47,013.44) Dollars.

RESOLUTION R-2025-317

The regulations of outdoor burning in Lawrence County; and

WHEREAS, the County Commissioners are desirous of providing for the health, safety and welfare of the people of Lawrence County; and

WHEREAS, the County Commissioners in cooperation with its volunteer fire fighting organization and the Pennsylvania Bureau of Forestry is desirous of regulating the outdoor burning; and

WHEREAS, the County Commissioners are desirous of protecting the people of Lawrence in every possible way from the dangers and threats of uncontrolled and unsafe fires;

NOW THERFORE BE IT RESOLVED BY THE LAWRENCE COUNTY COMMISSIONERS, it is ordained as Follows:

1. Definition - Open burning is defined as the ignition and subsequent burning

of any combustible material (garbage, leaves, grass, twigs, litter, paper, vegetative matter involved with land clearing, or any sort of debris) out-of-doors in either a burn barrel, (screened or unscreened) fire ring, or on the ground. The use of propane or gas stoves, charcoal briquet grills, or the use of tobacco in any form is not covered under this act. *Campfires in campgrounds are allowed in fire rings that confine and contain the campfire, and where all flammable materials have been removed for a radius of 5 feet.*

- 2. Prerequisite Prior to the adoption the county shall have received a written recommendation from the district forester who has received or solicited verbal requests from at least ten fire chiefs or 50% of the fire chiefs in the county, whichever is less, from various sections of the county recommending and requesting the imposition of a temporary countywide burn ban on open fires.
- 3. Duration Any burn ban imposed under this section shall remain in effect for no more than 30 days. The county commissioners, upon the recommendation of the district forester may extend the ban for up to an additional 30 days.
- 4. Construction Any burn ban imposed shall supersede any municipal ordinance to the contrary.
- 5. Enforcement:
 - (a) Enforcing officials Any sworn police officer when available, including the Pennsylvania State Police, shall be responsible for enforcing the provisions of this act.
 - (b) Limitation Whenever a violation of this act occurs in a city, borough, incorporated town or township which has in effect an ordinance prohibiting open burning, the police officer may cite the violation under either the municipal ordinance or the county resolution.

Under no circumstances shall any person be cited for violations of both the county resolution and the municipal ordinance for the same violation.

- 6. Penalty A person who violates this act commits a summary offense and shall, upon conviction, be sentenced to any a fine of not more than \$100 for the first offense, \$200 for the second offense and \$300 for the third offense.
- 7. Effective Date The resolution shall require a minimum notice of 48 hours prior to the imposition of a temporary countywide burn ban.

Authority Act 1995-52 of the General Assembly of the Commonwealth of Pennsylvania. Discussion was held on the burn ban. Mr. Dave Allegro, Taylor Township Supervisor and Fire Chief stated he agrees with Mr. Chad Strobel and encourages the Commissioners to implement the burn ban. It is currently very dry out and after today's rain, there is no rain forecasted for the next week or more.

Moved by Mr. Kennedy, seconded by Mr. Sainato to approve said Resolution. Motion carried 3-0.

RESOLUTION R-2025-319

WHEREAS, the Board of Commissioners wishes to authorize a Letter of Intent to purchase St. Joseph the Worker Church and Campus, located at 1111 S. Cascade Street, New Castle, Lawrence County, PA 16101; and

WHEREAS, said Letter of Intent will offer \$600,000.00 to purchase St. Joseph the Worker Church and Campus from the Pittsburgh Diocese; and

WHEREAS, the Letter of Intent will also specify terms for usage and the continuation of the current food bank at the current location for 18 months at no cost or rent to the Diocese; and

NOW THEREFORE BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF COMMISSIONERS, that the Board enter into a Letter of Intent for the purchase of St. Joseph the Worker Church and Campus for \$600,000.00. Said purchase is contingent upon acceptance by the Pittsburgh Diocese and execution by both parties of a Purchase Agreement.
