WHEREAS, Lisa Zarilla, has served as the point person for programmatic and fiscal reporting for these grants, and is set to retire effective July 18, 2025;

WHEREAS, the Jail-Based Vivitrol Program (Grant #44334) includes administrative funds that can support such a consulting arrangement;

WHEREAS, failure to establish a short-term consulting arrangement may risk delayed reporting, loss of compliance, and disruption to County grant operations;

NOW, THEREFORE, BE IT RESOLVED, by the Lawrence County Board of Commissioners:

- 1. The Consultant Contract between Lawrence County and Zarilla Consulting LLC, for the provision of administrative, quality assurance, and grant reporting support services for the MAT/Outpatient Program is hereby approved.
- 2. The Board of Commissioners authorizes Lawrence County Corrections to execute the Consultant Contract on behalf of Lawrence County, and further authorizes the County Administrator/Chief Clerk to attest the execution of this agreement.
- 3. Compensation for consulting services shall not exceed \$4,800.00 annually, based on an hourly rate of \$40.00, with a maximum of 10 hours per month or 30 hours per quarter, to be paid through PCCD Grant Number 44334 2024 County Jail-Based Vivitrol Program.
- 4. The Consultant Contract may be terminated by either party with 30 days' written notice, or automatically upon expiration or withdrawal of applicable grant funding.

This resolution and the associated contract shall be in effect immediately upon adoption
