### **PUBLIC MEETING**

#### **MINUTES OF Monday, June 9, 2025**

The Lawrence County Election Board Meeting was opened with the Pledge of Allegiance to the Flag followed by a Moment of Silence.

The Lawrence County Election Board Meeting of Monday, June 9, 2025, was called to order by **Commissioner Dan Vogler**, at 9:00 am at the Lawrence County Commissioners Meeting Room. Deputy Chief Clerk, Vanessa Bayless called the roll.
