Registered Republican voters, 27,447 and registered Democrats, 22,144, no affiliation, 4,644. Deployment of election machines will begin on Wednesday, November 2, 2022. The public test of the machines will be held on Friday, November 4, 2022. Solicitor Medure explained that undated ballots are being segregated and waiting for the court's decision.
