PUBLIC MEETING

MINUTES OF Friday November 21 , 2025

The Lawrence County Election Board Meeting was opened with the Pledge of Allegiance to the Flag followed by a Moment of Silence.

The Lawrence County Election Board Meeting of Friday November 21, 2025, was called to order by **Commissioner Dan Vogler**, at 8:30 am at the Lawrence County Commissioners Meeting Room. Administrative Assistant, Ryan Anderson called the roll. APPROVAL OF MINUTES

ELECTION DIRECTOR'S REPORT

Mr. Germani stated there was a very successful turn out for this election with the 3 Judges. All the ballots have been counted. Broke ties today and will have the results up soon.

NEW BUSINESS

Mr. Medure stated that the Hickory Township supervisor race where Michael Dillow and Randy Brown, Mr. Dillow was not a registered voter in Hickory Township, and the race cannot be certified until both parties present in court and the President Judge will hear them in court. There was also a complaint with the election code. There was a handwritten post card that was sent out prior to the election that stated LWV voters, which is a potential violation of the election laws. They will be turning it over to the DA's office. In the borough of New Wilmington there were also individuals handing out material and in addition they are also going to be sent to the DA's office for investigation.
