The Lawrence County Election Board Meeting was opened with the Pledge of Allegiance to the Flag followed by a Moment of Silence. The Lawrence County Election Board Meeting of Tuesday September 23, 2025, was called to order by **Commissioner Dan Vogler**, at 8:30 am at the Lawrence County Commissioners Meeting Room. Administrative Assistant, Ryan Anderson called the roll. Those in attendance were **Commissioner Dan Kennedy, Commissioner Chris Sainato, Tim Germani, Susan Kite and no one from the New Castle News**. It was stated for the record that the meeting is being taped. Those wishing to speak shall be given five minutes. ELECTION DIRECTOR'S REPORT

Mr. Germani stated that there are 57,188 registered voters in Lawrence County to date, 30,029 Republicans, 19,812 Democrats, and 5,411 No Affiliation. Mr. Germani said that the mail in ballots will be out in the first week of October. They received a total of 5,357 requests for mail in ballots. October 20th is the last day to register, and the last day to apply for a mail in ballot will be October 28th, 2025.

NOW, THEREFORE BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF ELECTIONS, that:

1. The polling place for the City of New Castle NC 2-1 shall be moved from the New Castle High School located at 310 E. Lincoln Ave, New Castle, Pa 16101 to The Scottish Rite Cathedral located at 110 E. Lincoln Ave, New Castle, Pa 16101.
2. NOTICE of this change has been duly completed per Election Code Statute 25 PS 2726.
