PUBLIC MEETING

MINUTES OF Wednesday May 7, 2025

The Lawrence County Election Board Meeting was opened with the Pledge of Allegiance to the Flag followed by a Moment of Silence.

The Lawrence County Election Board Meeting of Wednesday May 7, 2025, was called to order by **Commissioner Dan Vogler**, at 8:30 am at the Lawrence County Commissioners Meeting Room. Administrative Assistant, Ryan Anderson called the roll. Those in attendance were **Commissioner Dan Kennedy, Tim Germani, Lynne Ryan, Carrie Hahn, Judy Martwinski, James Constant, Robin Singer and no one from the New Castle News**. WHEREAS, in the Township of North Beaver, District 1, the polling place was located at the North Beaver Twp. Building, 861 Mt. Jackson Rd., New Castle, PA 16102; and

WHEREAS, the North Beaver Twp. Building will not be available as a polling site due

to ongoing construction; and

WHEREAS, the County Board of Elections has received permission to vote at the North Beaver Township Fire Department located at 969 Mt. Jackson Rd., New Castle, PA 16102

NOW, THEREFORE BE IT RESOLVED BY THE LAWRENCE COUNTY BOARD OF ELECTIONS, that:

1. The polling place for the First District of North Beaver Township shall be moved from the North Beaver Twp. Building to the North Beaver Twp. Fire Dept., located at 969 Mt. Jackson Rd., New Castle, PA 16102.
2. **NOTICE** of this change has been duly completed per Election Code Statute 25 PS 2726.
