- Comprehensive Plan/Greenways Plans: Staff has been working with Forward Lawrence on several grant applications. Submitted to DCED For an update to our Comprehensive Plan. Two applications were submitted to DCNR, one planning and one development. Planning Grant for Master Site Plan Phase II at Quaker Falls. Development Grant for the Stavich Bike Trail Rehabilitation.
- CDBG: General administrative duties. FY2022 Ellwood City ADA Curb Ramp Project. This project will provide access to nineteen (19) non-conforming curb ramps in the borough. Awarded the contract at the December 17<sup>th</sup> Commissioners Meeting to Fryer Excavating and pre-construction meeting was held on April 8<sup>th</sup>. Submitted the FY2022 Modification for Shenango Township. FY2024 contract has been received for signatures. Submitted updated items to them for review and approval. Completed all required reporting in January.
- ARPA: General Administrative Duties. Quarterly report due at the end of April.
- SPC: Attended TTC meetings. Planning Directors Meeting. Attended the SPC Climate Pollution Reduction Grant Action Committee meetings. 2027 TIP Update is beginning and the deadline to return any projects is June 20<sup>th</sup>
- **NORTHWEST:** Attended the NW Planners Meeting. A regional BEAD application for Broadband expansion was submitted in January. Weekly calls with the Core Connect Committee have been happening ever since.
- RALC: Administering the Side Yard Program and Countywide Housing and Blight Remediation Program. Working on a Countywide Façade Improvement program and Ellwood City Façade Program. Waiting to hear from PHFA for Countywide Blight Remediation Program.
- GENERAL: Ellwood City Façade Program. CPDAP meeting. APA-PA Board Meetings.
   Forward Lawrence Board meetings. Regional HOME application with LCCAP.
   Meeting with Plain Grove Township, SPC and PennDOT for bike route. Assisting the New Castle Library with their Keystone grant. Liquid fuel applications are due from the municipalities at the end of April.

- 4. **Forward Lawrence:** Ben Bush addressed the board stating that they have about \$380,000 available to lend to small businesses in the county. They can lend up to 50% and the business needs to have a private loan for the other percentage. The Steelite project is well underway and is currently on a 14-month schedule. Waterlines are being installed at Stonecrest Business Park and along Route 18. The property should be ready by June. There are four lots that could have the potential for 1.5 million square feet under roof. They have had inquires on every lot and multiple on two of them. An Industrial Sites Assessment has just been completed for the county.
