This form is a statement of interest only. Receipt of application does not commit the Redevelopment Authority of Lawrence County to transfer property. Application will not be processed unless completed in its entirety and the entire fee and recording fees are paid in full. The Redevelopment Authority reserves the right to reject any application. If the Redevelopment Authority receives two (2) or more applications for the same property, the final decision to transfer property to any applicant rests in the sole discretion of the Redevelopment Authority. The Redevelopment Authority transfers property by quit claim deed. Title insurance, if desired, is the responsibility of the applicant/purchaser.

Do **NOT** fill out this application if:

- You own *any* real property in Lawrence County that violates *any* local codes or ordinances.
- You own <u>any</u> real property in Lawrence County that is tax delinquent.
- You have <u>any</u> liens or judgements against you that have not been satisfied.
- You were the prior owner of any real property in Lawrence County that was transferred as a result of tax foreclosure proceedings.

The above conditions <u>disqualify</u> a property owner from acquiring land through the Lawrence County Redevelopment Authority.
