SUBDIVISION:

The division or re-division of a lot, tract, or parcel of land into two (2) or more lots, tracts, parcels, or other divisions of land, including the changes in existing lot lines. Includes Lot Consolidations.

LAND DEVELOPMENT:

The improvement of one (1) lot or two (2) or more contiguous lots, tracts, or parcels of land for any purpose involving a group of two (2) or more residential buildings, or one (1) or more nonresidential buildings on a lot or lots.

QUESTIONS TO ASK:

Is my lot large enough to subdivide?
What provision will be made for wastewater?
What is the nature and extent of access to the property?
Does this project fit with local zoning and building requirements?
Who will prepare the plans?
Will stormwater or erosion and sedimentation be affected?

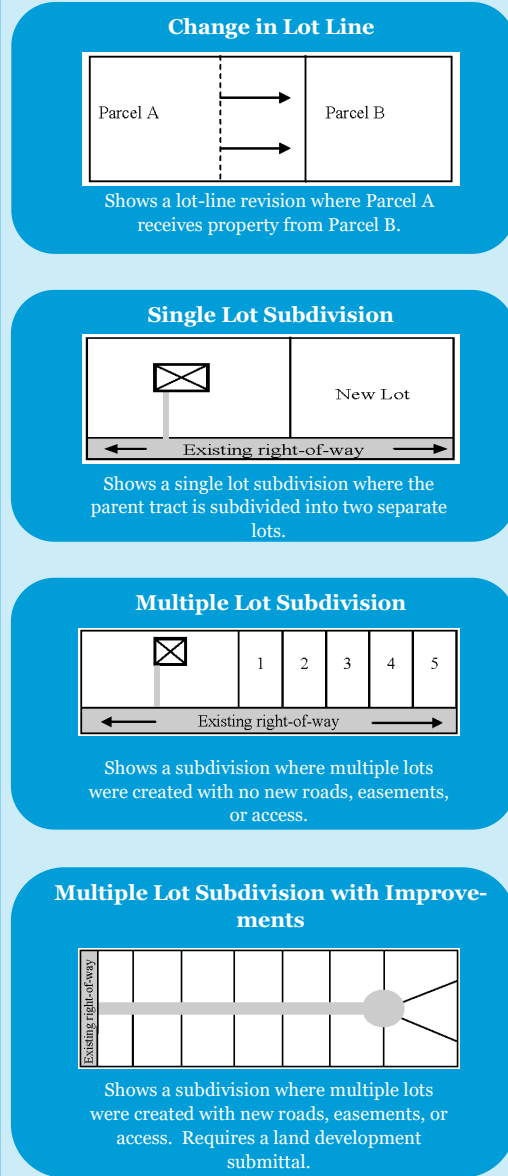
