The Lawrence County Prison Board Meeting Wednesday, March 22, 2024, was called to order by Chairman District Attorney Joshua Lamancusa, at 8:31 am at the Lawrence County Commissioners Conference Room. NEW BUSINESS

Mr. Lamancusa stated that the need for this special meeting of the Lawrence County Prison Board was necessitated by the executive session that was held previously on March 20, 2024. Mr. Lamancusa explained that there is a need for the board to take action and empower the Warden to make hiring decisions without a prison board vote. This would give the Warden more flexibility in hiring and this expansion of this authority would be limited to hiring decisions only. Mr. Lamancusa explained that the newly proposed hiring process would be as follows: The prospective candidate for

employment would submit an application for county employment, a background check would be completed by the Intelligence Officer at the Lawerence County Jail, the District Attorney's Office would provide any additional relevant information regarding the applicant and/or application, and then the application would be distributed to the Prison Board for any relevant input regarding the application, the applicant and/or the process. Ultimately, the hiring decision would be reserved to the Warden and his decision would be final after considering all input from Prison Board Members.

Motion made by Mr. Vogler, seconded by Mr. Sainato permitting the Warden to unilaterally make hiring decisions independent of the board. Motion carried 7-0.
